22. LABOR CATEGORY DESCRIPTIONS AND QUALIFICATIONS

Law Enforcement and Security Specialist (LESS) – Level III

Minimum Education/General Experience. Meets educational requirement of MS degree or possesses a minimum of twenty years of relevant technical and programmatic experience.

Functional Responsibilities. The LESS-III is a senior-level subject matter expert who assists client organizations in developing and implementing programmatic solutions to complex law enforcement and/or security challenges. The LESS-III employee provides fully-developed and integrated program support in the form of plans, policies, procedures, training, and organizational adaptations that achieve client-determined strategic goals and operational objectives. Recommended programmatic solutions are based on discerning analysis and comprehension of issues within the client's operational environment and organizational culture. At this level, employees possess an in-depth and current understanding of National Security issues, to include existing and emerging threats, with a working knowledge of national preparedness directives and planning guidance including the National Incident Management System, Incident Command System, National Response Plan, National Infrastructure Protection Plan, and Capabilities-Based Planning. Knowledge and expertise encompasses law enforcement, counterterrorism, critical infrastructure protection, homeland security, crisis management, emergency management, and response disciplines. LESS-III employees have foundational backgrounds in operational and/or investigative fields with experience managing significant law enforcement or security-related programs or projects at the national level. Support may include training design and development using Instructional Systems Design principles, as well as the design and management of exercises and evaluations compliant with current government programs and practices (e.g. HSEEP). The position is normally filled with personnel who possess an active security clearance or who are eligible to obtain one.

Law Enforcement and Security Specialist (LESS) – Level II

Minimum Education/General Experience. Meets educational requirement of BA/BS degree or possesses a minimum of fifteen years of relevant technical experience.

Functional Responsibilities. The LESS-II is a subject matter expert who fills a major role in projects supporting law enforcement and security clients. The LESS-II employee provides plans, policies, procedures, and training that contribute to a client's goals and objectives. At this level, employees possess a sound understanding of law enforcement and security issues, with in-depth knowledge of operational and tactical solutions.

Knowledge and expertise encompasses law enforcement, the protection of critical assets, counterterrorism, homeland security, crisis management, emergency management, and response disciplines. LESS-II employees have established backgrounds in operational and/or investigative fields with experience in significant law enforcement or security-related programs or projects. Support may include training content development and delivery, as well as the development of exercises and evaluations compliant with current government programs and practices (e.g. HSEEP). The position is normally filled with personnel who possess an active security clearance or who are eligible to obtain one.

Law Enforcement and Security Specialist (LESS) – Level I

Minimum Education/General Experience. Meets educational requirement of BA/BS degree or possesses a minimum of ten years of relevant technical experience.

Functional Responsibilities. The LESS-I typically supports project execution towards achieving a client's goals and objectives. At this level, employees possess a practical working understanding of law enforcement and security issues, with an emphasis on procedural and tactical solutions. Knowledge and expertise may include law enforcement, the protection of critical assets, counterterrorism, homeland security, crisis management, emergency management, and response disciplines. LESS-I employees have directly relevant backgrounds in operational and/or investigative fields within the law enforcement or security communities. Support may include training delivery, as well as execution of exercises and evaluations. The position is normally filled with personnel who possess an active security clearance or who are eligible to obtain one.

Project Support Specialist

Minimum Education/General Experience Meets educational requirement of an Associates degree or possesses a minimum of ten years of relevant experience.

Functional Responsibilities The Project Support Specialist (II) provides administrative support to projects. This labor category is staffed with personnel capable of applying MS Office and other software applications; providing logistical support to training deliveries, exercises and evaluations, as well as providing general administrative support to programs/projects.
